- b. External Factors: External factors are influences from outside the adolescent that encourage certain behaviors experienced by adolescents, usually characterized by violence, rebellion, crime, etc., which can be imitated by students. (Ummu Hani dan Hafidz, 2014)

PAI teachers are responsible for preventing adolescent delinquency behavior because being a teacher is a professional educator. Implicitly, they have accepted and assumed some of the educational responsibilities that parents bear. By handing over your child to an educational institution, you are simultaneously giving part of the responsibility of your child's education to the teacher.
